

PRIVACY POLICY

This is the Privacy Policy of G-TEC GROUP B.V. (hereinafter referred to as "G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA," "we," "us" or "our"), a company having its address at Bolderweg 2, 1332AT Almere. G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA is registered with the Chamber of Commerce under number 866048716. Our Privacy Policy explains how we collect, use, share and protect information in relation to our website www.g-teceurope.com (the "Service"). We collect this information when you visit our website with your computer, tablet, phone or smartwatch ("Computer"). We process personal data in a manner that is in accordance with the General Data Protection Regulation (the "GDPR"), the GDPR-based legislation and the other current privacy legislation.

By using the Service, you understand and agree to the collection and use of information in accordance with this Privacy Policy. Our Privacy Policy applies to all visitors, users, and others who access the Service ("Users").

What kinds of information do we collect?

Information you provide

We collect the following information you provide us with directly:

- a. Your username, password and e-mail address when you register for an G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA account;
- b. Profile information that you provide for your user profile;
- c. Communications between you and G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA (e.g., we may send you Service-related emails);

Log file information

We collect information that your browser sends whenever you visit our Service. This log file information may include information such as your computer's Internet Protocol address, browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages and other statistics.

Analytics services (non-personally identifiable information only)

We use third-party analytics tools to help us measure traffic and usage trends for the Service. These tools collect information sent by your device or our Service, including the web pages you visit, add-ons, and other information that assists us in improving the Service. The tools use 'cookies', which are text files placed on your device, to collect your log information and behavior information in an anonymous form. Cookies cannot damage your device or the files on your device. We collect and use this analytics information with analytics information from other Users so that it cannot reasonably be used to identify any particular individual User. With respect to Google Analytics, although Google Analytics plants a permanent cookie on your web browser to identify you, the cookie cannot be used by anyone but Google. Google's ability to use and share information collected by Google Analytics about your visits is restricted by the Google Analytics Terms of Use and the Google Privacy Policy. You can prevent Google Analytics from recognizing you on return visits by disabling cookies.

DoubleClick Cookies

Google, as a third-party vendor, uses cookies to serve ads on our Service. Remarketing

Purposes of processing data

By using our Service, you leave certain information with us, for example by creating an account. Communications

How is this information shared?

We will not rent or sell your information to third parties outside G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA.

Change of control

If we sell or otherwise transfer part or the whole of G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA or our assets to another organization (e.g., in the course of a transaction like a merger, acquisition, bankruptcy, dissolution, liquidation), your information collected through the Service may be among the items sold or transferred. The buyer or transferee will have to honor the commitments we have made in this Privacy Policy.

Legal requests and preventing harm

We may access, preserve and share your information in response to a legal request (like a search warrant, court order or subpoena) if we have a good faith belief that the law requires us to do so. We may also access, preserve and share information when we have a good faith belief it is necessary to: detect, prevent and address fraud and other illegal activity; to protect ourselves, you and others, including as part of investigations; and to prevent death or imminent bodily harm. Information we receive about you may be accessed, processed and retained for an extended period of time when it is the subject of a legal request or obligation, governmental investigation, or investigations concerning possible violations of our terms or policies, or otherwise to prevent harm.

Safety and security

G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA has taken appropriate technical and organizational measures by using the latest technologies to protect your information against loss or unlawful processing. We use safeguards to help keep the information collected through the Service secure and take steps (such as requesting a unique password) to verify your identity before granting you access to your account. However, G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA cannot ensure the security of any information you transmit to G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA or guarantee that information on the Service may not be accessed, disclosed, altered, or destroyed. We request you to do your part to help us. You are responsible for maintaining the secrecy of your unique password and account information, and for controlling access to emails between you and G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA, at all times. We are not responsible for the functionality, privacy, or security measures of any other organization.

International transfer

Your information may be transferred to, and maintained on computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction. If you are located outside Netherlands and choose to provide information to us, please note that we transfer the information to The Netherlands. Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

Retention period

In accordance with the law, G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA does not retain data any longer than is required for attaining the purposes for which they were collected unless G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA is obliged to do so based on a legal provision.

Inspection and correction

If you wish to know which of your data G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA has recorded or if you wish to amend or remove data that you cannot amend via your account, please contact G-TEC GROUP B.V. / G-TEC EUROPE / G-TEC USA.
